The Grand opening of the Kermit McKenzie playfield will be held March 23, 2018. Mr. Cora commended Mr. Bauer and Ms. Tonascia for a great job and for their patience during the playfield renovation. Mrs. Alvarez has scheduled kindergarten registration next week at Mary Buren. Summer Academy vacancies were posted today and two post Special Education positions have been posted. P.E. teacher candidates have been interviewed for a new position at McKenzie School for the 2018/19 school year.

#### A. General Functions

- 1. Board Policy Review BP 4119.22 Personnel Dress and Grooming
- 2. Board Policy Review BP 1112 Community Relations (Media)
- 3. Strategic Plan Input from Board
  - a. The five LCAP Goals are student achievement, safe & secure schools, technology, promoting societal values, and parent engagement.
  - b. Examples of Enrichment and Intervention programs are MESA, BAND, Ballet Folklorico, ASES, ASB, intervention classes, homework club, athletics and AVID.
  - c. We can strengthen the enrichment & intervention programs if we can afford to pay teachers to work after their classes. It's a different experience for students than in the classroom. Offer a program such as GATE where advanced/accelerated students are offered a "zero" period before school. Have classes that focus on Math.
  - d. Class times are currently 40 minutes. Switch to block scheduling to give students more time to improve achievement. Electives are wonderful but students need extra reading and math.
  - e. Keep classes under 30 students,
  - f. Address the social and emotional needs of students. Students can be supported and higher academic success can be achieved with lower class sizes.
  - g. The District needs a better balanced curriculum. The science program is not healthy at our schools. Science needs to be emphasized as well as English Language Arts and math.

## Parent Involvement -

- a. Coffee with the superintendent, DELAC meetings, watchdogs, dads and donuts. PTO, back to school night, carnival, school site council, parent conferences, coffee with the principal, student of the month, Christmas program, jog-a-thon, science fair, promotional dance, parent conferences, , and open house.
- b. Programs at Little House by the Park such as resource and referral, clothing assistance, holiday baskets, GED classes, and English as a second language.
- What change or changes should we do to improve parent involvement.
  - a. Campuses should be open to parent involvement.
  - b. Go to where the parents are to talk to them.
  - c. Try to educate the parent so they will engage in dialog.
  - d. Ask the parents what they want to be taught, for example, in the past some parents said they wanted to be able to speak English at a Kindergarten grade level. We should offer them that opportunity.
  - e. Emphasize the "why." We need to say why parents should come and how will it benefit and affect them.
  - f. Make sure the timing of functions are set to maximize parent participation and offer food at meetings during meal times.
  - g. At Kermit McKenzie parent involvement is an enormous benefit to students. Have the Jr. high school principal speak to parents at Mary Buren to stress the need for parents to stay involved and

- provide a  $4^{th}$  and  $5^{th}$  grade parent orientation for Kermit McKenzie.
- h. Include the administrators the next time strategic planning is discussed in order to collaborate.
- i. Create evening classes for teachers to learn basic Spanish at our schools. It would be beneficial for teachers to learn more about the community.
- j. Would like to see a balanced curriculum, which has to start in kindergarten classrooms.
- k. Bridge curriculum from Mary Buren to Kermit McKenzie to help the transition from elementary to Jr. high school.
